I have read, understand and accept the following:

Services: Client understands that the Services are provided by separate and independent travel vendors ("Vendors"). Endless Travel shall not be responsible for the operation, control, performance, or other provision by Vendors of the Services. Hence, Client agrees that Endless Travel acts only as a sales agent for Client to acquire the Services for Client's benefit including agreeing to Vendor's service agreements on Client's behalf. Endless Travel shall not be responsible for any delay, interruption, cancellation, or other disruption to the Services or other travel plans and shall be excused from performance where such delay or disruption is due to events beyond Endless Travel's control, including, without limitation, strikes, weather or natural disasters, terrorism or any destination dangers ("Unforeseen Incident").

Documentation: Travel documentation appropriate for entry to your itinerary destinations, such as passports, visas & inoculation certificates, remain each traveler's responsibility. It is the traveler's responsibility, to make certain that they have proper immunizations before travel. Please see your health care provider for advice. Endless Travel, LLC will advise required documentation, including exact spelling of name on government id's, but travelers who do not meet advised requirements will be denied boarding. Valid passports are required for all international destinations. If a passport is required to travel, the expiration date must be at least six (6) months following the return date of planned travel. Each foreign country holds different views of past criminal offenses-if you have a current or past offense, please contact the country directly for entry and exit requirements. Travelers with DWI or DUI records should check whether current rules exclude admission to foreign destinations. Endless Travel, LLC feels it is an invasion of privacy for members of our staff to make such an inquiry and these requirements remain the traveler's responsibility.
